RESIDENTS MUST SHOW A PERMIT.

TO OBTAIN PERMIT:

Permits are not needed for disposal of 100% grass/leaves. ONLY biodegradable paper bags may be left, plastic bags must be taken away by you.

Permits are obtained from the DPW Office located at 384 Osgood St –
Monday - Friday 8:30am to 4:30pm

Residents MUST show PROOF of Residency

LANDSCAPERS **MUST PROVIDE** the North Andover Resident's NAME, ADDRESS, and PHONE NUMBER where the material is coming from.

The DPW reserves the right to refuse access to any resident or landscaper that does not adhere to these guidelines.

| 1. Car Trunk | \$7.00 YEARLY PERMIT
(Expires in Dec of Year issued) |
| 2. Van or SUV (Rear only - Seats UP) | \$7.00 YEARLY PERMIT
(Expires in Dec of Year issued) |
| 3. Van or SUV (FULL load – Seats DOWN) | \$5.00 PER LOAD PERMIT |
| 4. Pickup Truck (level load) | \$5.00 PER LOAD PERMIT |
| 5. Pickup Truck (Over loaded – strapped down) | \$30.00 PER LOAD PERMIT |
| 6. Pickup Truck with added sides | \$30.00 PER LOAD PERMIT |
| 7. Dump Truck – Up to 6 Wheels | \$30.00 PER LOAD PERMIT |

Any vehicle larger than a 6-Wheel Dump Truck is PROHIBITED

**PLEASE SEE REVERSE SIDE FOR ACCEPTED MATERIALS AND
PROPER DISPOSAL SITE INSTRUCTIONS.**

THE AREA IS FOR RESIDENTIAL YARD WASTE ONLY!!
(Absolutely No Lot Clearing!)

- Materials must be placed in the area designated by the onsite attendant
- Load sizes are listed on the reverse of this notice and you must purchase permits from the DPW office prior to arriving at the Recycling Area.
- Disposal of 100% grass/leaves in PLASTIC BAGS **MUST BE EMPTIED AND REMOVED FROM THE SITE.**

WE WILL ACCEPT (but also have the right to refuse):

GRASS & LEAVES ONLY – LOOSE OR IN BIODEGRADABLE PAPER BAGS
NO PERMIT NEEDED BUT YOU MUST BE ABLE TO SHOW PROOF OF RESIDENCY.

PERMITS ARE NEEDED FOR THE FOLLOWING:

SAND GRAVEL STONE CLEAN BRICKS CLEAN FILL BRUSH
TREE LIMBS LOGS(3' OR SMALLER)

UNACCEPTABLE MATERIALS

- **ABSOLUTELY NO TREE STUMPS**
- **NO LUMBER OF ANY TYPE***
- **NO CONCRETE, CONCRETE BLOCKS***
- **NO CEMENT OR BRICKS WITH MORTAR***
- **NO LOT CLEARING** (INCLUDING REMOVING TREES FOR A POOL)
- **NO CONTRACTING /CONSTRUCTION DEBRIS***
(SHINGLES, FENCES, RUBBLE, ASPHALT....)
- **NO HOUSEHOLD RUBBISH****
- **NO HOUSEHOLD RECYCLING****

PLEASE BE RESPONSIBLE - VIOLATORS ARE CAUSING THE AREA TO BECOME
DIFFICULT TO MANAGE – SAFETY IS OUR PRIORITY
